MSBA(Mass. School Building Authority) Update

Superintendent Clenchy introduced Dr. Jake Foster. Dr. Foster provided his bio. on his work with the MSBA and provided a powerpoint presentation reviewing the MSBA Core Program process and the work of the focus on educational programming.

Feasibility Study Data

Pat Marone provided a powerpoint presentation on the process of a feasibility study reviewing how the study will be paid for, the process of the borrowing, and what area districts have done for budget planning. Ms. Marone advised not to request an exact amount on the town warrants but wordage of "an amount not to exceed". The committee discussed borrowing and town meeting timelines and communication.

Superintendent Clenchy advised she is requesting the school committee to vote to establish an ad hoc subcommittee for the communication of the MSBA project. Ms. Vivirito and Ms. Sanfilippo volunteered to sit on the committee.

Potential 3rd Bolton SC Member Presentation

Dr. McCarthy provided a review of the process for determining School Committee membership. Dr. McCarthy provided a powerpoint presentation of this process. Dr. McCarthy reviewed the spreadsheet from DESE for determining SC membership based on the certified census data from the member towns.

Dr. Mary McCarthy moved In accordance with The Nashoba Regional School District Agreement (Section 1.(C) that "The population of the participating towns shall be determined every five (5) years in accordance with the town's annual census as certified by the respective town clerks, and since the Nashoba Regional District School Committee has on 2/12/20 reviewed the town annual census populations of Bolton, Lancaster and Stow as certified by the respective town clerks with the result that change is warranted in the number of members to be elected to the Regional District School Committee, I move that we vote to add one additional member to Bolton, Lancaster and Stow so that Bolton has three members, Lancaster has four members and Stow has four members for a total of 11 members elected to the Regional District School Committee and according to the Regional District School Committee Agreement, "such change shall be effective at the annual town election following the certification of the census (Section1.(D).seconded by Stephen Rubinstein IN FAVOR: Kathy Codianne, Stephen Rubinstein, Elaine Sanfilippo, Dr. Mary McCarthy, Leah Vivirito, and Mike Horesh OPPOSED: Joseph Gleason VOTED AND PASSED. (6-1-0)

FY21 Budget Update

Superintendent Clenchy provided a powerpoint presentation of where the budget is at as of today advising she has already made deep cuts in the budget and reviewed the departments where cuts were made, the budget drivers, where the towns advised they need the assessments to be, the reductions still need to be made equal \$844,699 to reach the towns requests. The committee discussed the use of E&D and the effects on programs and staff if deeper cuts are made.
