**Superintendent Employment Contract**

Chairperson Codianne advised the School Committee meet in Executive Session to discuss a Section in her employment contract; “Section 9. Resignation: There shall be no penalty for

release or resignation by the Superintendent from this contract, provided no resignation shall become effective until the close of any school year in which this contract is in effect, or upon (180) one hundred eighty days' notification from the Superintendent unless the Committee fixes a lesser period of time at which the resignation or release is to take effect". Chairperson Codianne advised the Superintendent exercised this section and tenured her resignation. Superintendent Clenchy read her letter of resignation. Chairperson Codianne thanked the Superintendent for her service and dedication to the district and her role in the leadership of the district.
