Several School Committee members expressed they are not pleased with a budget that presents cuts but acknowledged the financial needs of the towns and advised conversation be had with the Town FinComm to work together to stop the cycle of future cuts in the school budget.

Full Return Update

Dr. Maguire provided a PowerPoint Presentation updated on student full return, detailing the timeline, the K-8 enrollment for return and how many students have opted for the remote academy. Superintendent Clenchy advised that guidance from DESE has not been very clear and constantly changing but the Admin Team at NRSD is ahead of the guidance and is ready to full return for K-8, the high school presents a different set of challenges.
