Salary Range for Non-Union Personnel

Chairperson Codianne advised at the April 5th Personnel Subcommittee meeting, the HR Director, Ann Marie Stoica, presented the Committee with information relative to Professional Staff Salary Schedules, pursuant to Policy GCBA. This information includes "methods used in calculating salary ranges", "comparable data", and a proposal for salary ranges for all non-union salaried personnel. While the Personal Subcommittee intended to bring forward a recommendation for non-union salary ranges, the Personal Subcommittee instead recommends that this work be scheduled at a School Committee workshop so that there is adequate time to process this information, ask questions and receive appropriate professional development to assist in decision making. While policy GCBA sets a deadline for completing this task, an arguments could be made to hold the workshop with the new Superintendent Additionally, the School Committee has not engaged in this process in previous year.
