# **FY22 BUDGET PUBLIC HEARING**

Superintendent Clenchy and Pat Marone, NRSD Business Manager provided a PowerPoint presentation reviewing the proposed FY22 Budget, E &D , town assessments, expenditure points, budget drivers, budget breakdown of expense areas, historical budget trends, and revenues by source. Superintendent Clenchy advised there are currently 1.2 million dollars in unspecified cuts in the proposed budget. The School Committee will vote on the budget at the March 10<sup>th</sup> School Committee Meeting.

Laura Roberts - Bolton, Could the Superintendent provide an overview of the balance left in E&D after the \$1,000.000 is used for this year's budget and how that compares to prior years? Is the amount contributed via vote by town meeting or some other path? I am interested in knowing what the path is to driving change.
