OLD BUSINESS

School Committee Meeting Venue Update

Dr. Maguire advised that Su Qi, Rob Frieswick, Aleta Masterson and members of the local access TV Stations met with CCS at Center School to evaluation equipment needs for hosting meetings there, their quote (which is roughly \$46,000) is in the meeting packet. Dr. Maguire advised they have reached out to other district and most are meeting remotely. Rich Eckel was scheduled to meet today with Qi and Aleta to test his idea on a solution but that meeting was postponed. Mr. Eckel advised if the equipment can be used for Town of Stow events the Administration should explore the opportunity for the Town of Stow to cover the costs.
