#### **Student Advisory Report**

Ms. Kirschbaum reported;

- DECA members attended the Fall State Leadership Conference at Bentley University today as well.
   Students got a tour of the market research center and the stock room and also learned how to dress for success.
- Nashoba field hockey showed support for their teammate Michelle, who is battling cancer, by compiling some of the videos they make for her during each game into a "You Fight" youtube video. It is titled NFH Loves Michelle and currently has almost 3,000 views.
- The journalism students have recently launched a new website at cheiftainpress.net to cover both Nashoba and world news.

The regular season has come to an end and the post-season is about to begin!

- The golf team finished their season at 9-7 and placed 8<sup>th</sup> place in Central Mass.
- The cross-country teams ended the regular season with a record of 5-1. The boys team won the Wachusett Invitational and the League Championship last weekend.
- The boys soccer team has been playing well at the end of the season. The team finished their season on the road at Bromfield today.
