- School Building Project Visits
 Superintendent Downing visited town select boards to discuss procedures for incurring debt, and visited the Lancaster Council on Aging with Assistant Superintendent Friend to discuss the building project.

 Superintendent Downing presented a summary of work done to advance our strategic objectives and initiatives.
- NRSD FY24 Budget Update

Mr. Mulkerin reported that the budget decreased by \$105,861 to \$65,426,842, a 5.14% increase over FY 23. We are waiting to learn state funding numbers and our insurance, charter and school choice assessments, and the results of negotiations.

7:05 New Business

The presentation of the NRHS Program of Studies, originally scheduled to be last in the New Business section, was moved to the beginning of New Business.

Nashoba Regional High School Principal Dr. Kate Boynton presented the Program of Studies, which is found in the Meeting Materials. The Change Memo is an executive summary of changes made. The changes are also color coded, red being removed language, blue being new language, and there is language setting forth what was changed and the rationale for the change.

- a) Superintendent Formative Evaluation PD: Part II Personnel Subcommittee Chair Mr. Horesh presented training for the School Committee members outlining their task in completing the superintendent's formative assessment, the mid-cycle review of the superintendent's progress toward his goals. Ms. Cohen presented the goals, rubric and references to the strategic plan that are found in the evaluation formative report
- b) Superintendent Evaluation Formative Report Ms. Vivirito reminded the School Committee members that they will rate and give feedback to the superintendent, and that the goal is the Proficient rating. Though not expected by DESE in a superintendent's first three years, she said that Superintendent Downing had

received one Exemplary rating last year, so they should not be afraid to give that rating if deserved.

Superintendent Downing gave a formative evaluation report, which due to transparency efforts, has been updated to the School Committee every two weeks. Information showing progress toward strategic goals has been ongoing, and the Committee and community will continue to be updated as the year progresses.

c) Subcommittee Goals Check-In Goals of the subcommittees will be discussed during the subcommittee reports later in the agenda.

d) Hale DC Trip Donation

Hale Middle School received an anonymous donation of \$1,000 to help defray the cost of the Washington DC trip for student(s) who need the help.

Preschool / Extended Day Fee

Mr. Mulkerin is asking for a vote on fees presented several meetings ago, with one correction. To maintain the linear progression concern raised with the before school three-day rates, he is now proposing that the three-day before school rate be changed from

\$84.36 to \$81.03 monthly, and from \$843.69 to \$810.30 annually. This will remove the anomaly brought to light in the prior meeting.

- a) Budget and Warrant Mr. Horesh Reports Subcommittee has several goals relating to accessibility and visibility of the budget setting process.
